

Redemption Offer on MASwings

Terms and Conditions

A. Duration

- 1. The Redemption Offer on MASwings ("Promotion") is organised by Malaysia Airlines Berhad ("MAB") together with MASwings Sdn Bhd ("MASwings") and will run from 27 August 2018 until 5 September 2018 ("Promotion Period").
- 2. The travel period pursuant to this campaign is strictly from 28 August 2018 to 31 December 2018 ("Travel Period"). The entire flight journey, return or otherwise, must be within the Travel period.
- 3. The booking period will start at 00:00 on 27 August 2018, Malaysia local time (GMT +8) and will end at 23:59 on 31 August 2018, Malaysia local time (GMT +8).

Booking Period : 27 August 2018 – 5 September 2018 Travelling Period: 28 August 2018 – 31 December 2018

B. Eligibility and Participation

- 1. Any person who has fulfilled the criteria below is eligible to participate in this Promotion ("Participant"):
 - a. Be an Enrich member who has accrued the required Enrich Miles available in the respective Enrich member's account, without any breach of the applicable Enrich terms and conditions
 - b. Has sufficient Miles in his/her account in order to redeem an Enrich Award flight ticket(s).
 - c. Redemption is made during the Promotion Period and travel within the Travel Period.
- 2. The mechanics of the Promotion are as follows:
 - a. This Promotion is valid for travel on eligible Economy Class only and solely on selected MASwings operated flights.
 - b. Not eligible on codeshare flights, joint services or charter flights.

C. Redemption of Tickets

- 1. Enrich Members may redeem flight ticket(s) of Enrich Award under this Promotion during the Promotion Period only ("Redeemed Ticket").
- 2. The Redeemed Ticket shall be valid for travel within the Travel Period only.
- 3. A Redeemed Ticket must be booked and ticketed before/on 23:59 (GMT+8) on 5 September 2018 failing which, the Enrich Member will be ineligible for this Promotion and the normal miles will apply. No appeals and/or disputes will be entertained. Any flight ticket booked or redeemed/issued prior to this Promotion before 00:00 (GMT) on 27 August 2018 shall not be eligible for reissuance or refund for the purpose of this Promotion.
- 4. In the event member wishes to make any changes to an unutilized or partly utilized Malaysia Airlines Award Travel redemption ticket, any change fee charges/penalties will be in accordance with the applicable Fare Conditions and these Terms and Conditions. Any payments involving changes to a Malaysia Airlines Award Travel redemption (other than for refunds) must be paid with cash/credit card as specified in the Fare Conditions. For the purposes of calculating any such payments, the original fare or commercial ticket value (as referred to in the Fare Conditions) of the Malaysia Airlines Award Travel will be calculated as the remaining cash value of the unused ticket determined in accordance with the Fare Conditions.

Malaysia Airlines shall be entitled to cancel or invalidate any Redeemed Ticket if found to be in breach of any of these Terms and Conditions, Enrich Terms and Conditions or any other applicable rules and regulations of Malaysia Airlines.
- 7. Only point to point one way and mirror like return Online Enrich Awards are allowed. Any connecting flight will require two (02) separate tickets.
- 8. Enrich Member will NOT earn miles for Malaysia Airlines Award Travel redemption.
- 9. Enrich Member with insufficient Enrich Miles may redeem using the Miles + Cash redemption option. Miles + Cash is a full Award Travel that allows members to redeem Malaysia Airlines Award Travel with a combination of Miles and money in terms of cash or credit card, where applicable.
- 10. Member will NOT earn miles for the cash value paid for the Miles + Cash Award Travel redemption
- 11. All the Terms and Conditions for Miles + Cash redemption will apply if Miles + Cash redemption is used for this Promotion except that for this promotion, both the 'Cash' portion and Miles are not refundable. - 13. Enrich Miles required to redeem an Enrich Award must be redeemed from a single Enrich Account. Enrich Miles may not be combined from multiple Accounts in order to redeem an Enrich Award.
- 14. Redemption for infant and children (02 12 years) must be booked with an adult when redeeming online.
- 15. This Promotion is NOT valid on codeshare flights between MASwings and Malaysia Airlines.



- 16. All taxes including fees and surcharges (where applicable) are the responsibility of the Enrich Member/user of the Enrich Award and are due at the time of issuance, ticketing and/or at departure.
- 17. No refund is allowed for unused or partly utilized Award Tickets. Refund of taxes will be subject to new Fare Conditions.
- 18. Name change is strictly not permitted.
- 19. The Award Travel redemption miles are tied to fares and vary according to seat availability, passenger demand and seasonality which may limit the number of seats available for the Travel Awards on MASwings flight.
- 20. Seats under this Promotion are limited and shall be given on a first come first serve basis, subject to any applicable terms and conditions, rules and regulations of Malaysia Airlines.
- 21. Redemption Upgrades are not allowed for Malaysia Airlines Award Travel tickets.
- 22. The use of Enrich miles against this offer is subject to these Terms and Conditions and all other Terms and Conditions of the Enrich programme. The terms and conditions of the Enrich programme are subject to change at any time with or without notice.
- 23. Miles redeemed for an Award Travel is NOT refundable to the original account or used in exchange for a different Award Travel. MAB reserves the right to use the Participant's name, images, comments, materials relating to this Promotion and the results of this Promotion for the purpose of any announcement or promotional or marketing purposes in any media format and any media channels without any fee being paid. The Participant shall hold MAB free and harmless from any claims and/or liabilities whatsoever resulting from the usage or the reproduction of the submitted materials by MAB. - 5. MAB's decision on matters relating to the Promotion shall be final and absolute. No discussion, correspondence, enquiry, appeal or challenge by any of the Participants in respect of any decision of MAB shall be entertained.
