

# **Double Enrich Miles Accrual Campaign**

### **Terms and Conditions**

- 3. Enrich Members are entitled to earn Double Enrich Miles subject to the terms of the Promotion herein ("Double Enrich Miles").

- Change of travel date to an earlier date of travel from the original date after the booking/ticketing period is not allowed.
- Members will not be eligible for the Double Enrich Miles if date of travel is changed to an earlier flight from the original booking date after the promotion booking period is over.
- Travel to a later date of travel from the original date after the booking period, is allowed but travel must be within the promotion travel period.
- 13. This Promotion shall not be used in conjunction with any other promotional offer by Enrich or Malaysian Airlines Berhad ("Malaysia Airlines").
