

TERMS AND CONDITIONS

ENRICH HILTON (PROPERTIES IN MALAYSIA) E-VOUCHER REDEMPTION CAMPAIGN FOR ENRICH MEMBERS

Enrich Hilton (properties in Malaysia) e-voucher Redemption Campaign is organized by Enrich by Malaysia Airlines Berhad (Organizer)

[A] Redemption of Enrich Hilton RM50 e-Voucher

1. The e-voucher code is available for redemption during the campaign period published in the Enrich Website in a denomination offered with the amount of Enrich Points required specified in the campaign terms and conditions.
2. The amount of Enrich Points required for this campaign is, **5,000 Enrich Points for one (1) Enrich Hilton RM50 e-Voucher.**
3. The campaign period is as follows: -
 - Redemption period: Now – 31 December 2021, 11:59 PM
 - Usage period: Now – 31 December 2021 11:59 PM
4. The e-voucher can only be redeemed at Enrich Online and may not be purchased with cash or credit card.
5. Enrich member will receive an email upon successful redemption. The email will not state the e-voucher code redeemed but will state the steps on how to retrieve the e-voucher code from the MH Mobile App.
6. To obtain the e-voucher code, please download the MH Mobile App from Google Play Store or App Store.
7. Once redeemed, the e-voucher code will be loaded onto the MH Mobile App under MHVoucher section after redemption has been made at Enrich Online.
8. The e-voucher can only be downloaded by the member who redeems the voucher. Transfer of the e-voucher to other Enrich member (s) is not allowed.
9. Once redeemed, the e-voucher code is non-refundable and cannot be exchanged for cash in part or full.
10. The appropriate Enrich Points will be deducted from the member's Enrich account and will not be returned under any circumstances.
11. Enrich Members must have sufficient Points in their Enrich account to redeem the e-voucher code. In the event, Member does not have sufficient Points, the redemption request will not be processed and top up with cash/credit card is strictly not allowed.
12. Enrich Member who does not have sufficient Enrich Points to redeem this Enrich 'Hilton' e-voucher, may Buy Points via Enrich Online prior to redeeming.
13. The Redemption is on full Points term only; no Points and Cash terms is allowed.

- Once redeemed, the Enrich Hilton e-voucher shall be deemed to be fully utilized, cannot be exchanged or substituted for other redemption campaign or other promotions offered by Malaysia Airlines.
- The 'Redeem Now' tab on the Enrich Hilton RM50 e-voucher can be swiped ONCE only. The e-voucher is considered used once the 'Redeem Now' tab is selected. This transaction cannot be reversed.
- To use this e-voucher the member must be present at the restaurant.
- Combination of multiple Enrich Hilton e-voucher code is allowed for single transactions.
- The e-voucher code is good for a one-time purchase only. No minimum purchase is required for the e-Voucher redemption.
 - If the total purchase is less than the value of the e-voucher code, no refund will be given.
 - If the total purchase more than the value of the e-voucher code, you are required to top-up and pay any balances.
- Top up by cash/credit card is required for receipts/bills more than the voucher value. Any balance value will not be refunded should the value of the vouchers used is more than the total payable amount.
Example: In the event where the value of the RM 50 vouchers used is more than the total payable amount in the restaurants, the restaurant will not refund the balance. (e.g.: total bill costs RM320, customer uses 7x RM50 vouchers for payment, the balance of RM30 will not be refunded to the member)
- The e-voucher code validity is limited, and members should use the e-voucher code by 31 December 2021. There will be no re-issuance of the e-voucher code upon the expiry date. No replacements or extension will be given for expired e-voucher code.
- Participating restaurants will not impose restrictions/blackout periods for voucher utilization except where the blackout dates as follows applies: -

12. The e-voucher can only be used for dining in (excluding alcoholic beverages) and must be in a single receipt. Take-outs / take-aways are allowed, unless otherwise stated by the participating restaurants. Delivery is not allowed.
13. Members are not allowed to split the receipt / bill.
14. Members will not earn Enrich Points for the cash portion paid or for the e-voucher redeemed.
15. Prior reservation is required and seating arrangement for walk in customer is subject to availability, unless otherwise stated by the participating restaurants.
16. The e-voucher can only be used for payment excluding any taxes or service charges. The taxes or service charges should be paid by the member either in cash or credit separately.
17. Enrich and Hilton reserves the right to cancel or modify any order or revoke the use of the e-voucher code for any reason, including the following circumstances: fraudulent purchasing activity, abuse or used in bad faith.
18. Enrich and Hilton will not be liable and/or be required to offer replacement e-voucher code, discounts, credits, cash or otherwise compensate customers for:
 - incorrectly redeeming this e-voucher,
 - the inability to redeem the e-Voucher due to technical issues,
 - discontinued or cancelled e-voucher; or
 - improper use of the e-voucher
19. Members are to contact Enrich at enrich@malaysiaairlines.com immediately from the date of redemption to report any issues pertaining to the redemption of the Enrich Hilton RM 50 e-voucher. Request after 03 days from the date of redemption will not be entertained and will be deemed as redeemed and utilized. No Points refund or replacement of e-voucher will be accommodated.
20. For issues pertaining to the usage of the Enrich Hilton RM 50 e-voucher, members are to contact the respective participating restaurants.
21. Members are to contact Hilton for any issues involving the service delivery or food service by 'Hilton'. Enrich will not be liable for any issues involving the above.
