



WIN MEET & GREET PASSES WITH ILIZA SHLESINGER

Terms and Conditions

A. Duration

1. The “**WIN MEET & GREET PASSES WITH ILIZA SHLESINGER**” (“Contest”) is organised by Malaysia Airlines Berhad (“MAB”) and will run from 1 May 2019 (12:00AM, Malaysian time) to 31 May 2019 (11:59PM, Malaysian time) (“Contest Period”).

B. Eligibility and Participation

1. Any person who has fulfilled the criteria below is eligible to participate in this Contest (“Participant”):
 - a. Be 18 years old or older;
 - b. Be an Enrich Member. Non-member can register for membership at <https://www.malaysiaairlines.com/enrich-portal/user-registration.html?cid=LOL> and must register before submission of entry
2. The following person(s) shall not be eligible to participate in this Contest:
 - a. Permanent, contractual & temporary employees of MAB (including those within the Malaysia Aviation Group Berhad) and their immediate family members; and
 - b. Representatives, business partners and/or agents (including advertising and promotion agents and their immediate family members) of MAB.
3. The mechanics of the Contest are as follows:
 - a. Participants must purchase ‘Iliza Shlesinger ticket(s) within the Contest Period.
 - b. Participants must purchase ‘Iliza Shlesinger ticket(s) by 31 May 2019 (11:59PM, Malaysian time).
 - c. Multiple purchases are allowed, however only one entry will be considered.
 - d. For the purpose of selecting the Winner, one (1) Participant will be randomly selected as a Winner.
 - e. One (1) Winner (“Winner”) will be contacted via email with more information on Meet and Greet Passes collection.

C. Prize

1. One (1) Winner (“Winner”) will receive two (2) Meet and Greet Passes with Iliza Shlesinger (“Prize”) at The Platform, Menara Ken TTDI, Kuala Lumpur on 16 June 2019.
2. The Winners will be notified by email (“Winning Notification”) within five (5) working days from the end of the Contest Period or such other date as decided by MAB at its absolute discretion. The Winning Notification will include instructions on how to claim the Prize and to request for Winners’ verification and confirmation of personal details to MAB.



3. Reasonable efforts will be made to contact the Winners. If the Winners do not respond within the stipulated time, the Winners will be disqualified, and MAB reserves the right to offer the Prize to the next Participant based on the judges' sole and absolute discretion.
 - MAB will attempt to contact the Winner at least three (3) times. If the first attempt to contact fails, another two (2) attempts will be made to email the said Winners.
 - In the event the Winners are not contactable after three (3) attempts:
 - i. He/she will be disqualified, and no appeals will be entertained
 - ii. The next shortlisted Participant will be contacted until the Prize can be awarded.

4. The Prize is subject to the following terms and conditions:
 - a. The ticketing terms and conditions as stipulated on the ticketing website and on the printed tickets shall apply at all times.
 - i. One (1) Meet and Greet Pass admits 1 person ONLY
 - ii. No cancellation, changes and refund are allowed.
 - iii. The Meet and Greet Passes are non-refundable and non-exchangeable for cash or kind whether in part or in full.
 - iv. The Meet and Greet Passes are valid only on the date shown on the ticket
 - v. Lost or damage Meet and Greet Passes will not be entertained.
 - vi. Strictly NO photo, video and audio recording are allowed during the live show.
 - b. The Meet and Greet Passes provided are given on "as is" basis to the Winner and must be utilised for the 'Iliza Shlesinger Live In Kuala Lumpur' held at The Platform, Menara Ken TTDI, Kuala Lumpur on 16 June 2019.
 - c. The Meet and Greet Passes are excluding flight ticket(s) and shall be borne by the Winner.
 - d. MAB shall not liable for any additional or incidental costs, taxes, expenses, charges, fees, losses or damage incurred. Malaysia Airlines, its agents and employees shall not be liable for any loss or damage whatsoever suffered (including but not limited to indirect or consequential losses) or personal injury suffered or sustained in connection with or arising from the Prize.
 - e. MAB shall not be liable or responsible for any loss or damage suffered by the Winners or their travelling companion if the Winners or their travelling companion does not utilise the Prize as a result of any statutory requirements not met, Government travel warning or advisory applicable to the destination country and/or countries.
 - f. MAB shall have no obligation to substitute any alternative prize, cash equivalent or other compensation where the Winners and/or their travelling companion fails to utilise the Prize for any reason.

 6. Winners are responsible to ensure their travel documents are in order eg. passport, visa etc. Malaysia Airlines will not be liable under any circumstances should the Winner (s) is/are denied entry for improper or incomplete documentation or any other reasons not related to the airline.

1. All transportation, accommodation, personal costs and/or any other costs and/or related expenses that are incurred to attend/participate in this Contest and to redeem the Prize are the sole responsibility of the Participants.
2. MAB reserves the right to use, reproduce, edit and distribute materials submitted for this Contest for publication and/or display in any media format and any media channels without obtaining further prior permission and payment of any fees or royalty to the Participant.
3. MAB reserves the right to use the Winner's name, images, comments, materials relating to this Contest and the results of this Contest for the purpose of any announcement or promotional or marketing purposes in any media format and any media channels without any fee being paid. The Participant shall hold MAB free and harmless from any claims and/or liabilities whatsoever resulting from the usage or the reproduction of the submitted materials by MAB. This clause shall survive the expiration of this Contest Period.
4. MAB, at its sole and absolute discretion, reserves the right to disqualify any Participant and revoke or forfeit any Prize at any stage of the Contest without prior notice if:
 - a. The participant is not an eligible Participant;
 - b. The Participant fails to fully comply with the Terms and Conditions stipulated herein;
 - c. Entries are incomplete;

 - e. MAB has, at its sole discretion, any reason whatsoever to believe that such Participant has attempted to undermine the operation of the Contest in any way whatsoever, including but not limited to fraud, cheating or deception.
5. MAB's decision on matters relating to the Contest (including, but not limited to the selection of the Winner) shall be final and absolute. No discussion, correspondence, enquiry, appeal or challenge by any of the Participants in respect of any decision of MAB shall be entertained.
 6. Prizes must be collected in accordance with the mode to be specified by MAB, at its sole and absolute discretion, upon notification of any winnings.  13. The main language of the Terms and Conditions shall be the English language. Any translation to any other language than English shall be for convenience only. Should there be any discrepancies between the English Terms &



Conditions and the translated version, the English Terms & Conditions shall prevail.

14. By virtue of an entry to the Contest, the Participants signify their absolute and unconditional acceptance and agreement to all the Terms and Conditions stipulated herein.
15. MAB reserves the right to cancel, terminate or suspend the Contest without any prior notice. For the avoidance of doubt, any cancellation, termination or suspension by MAB of the Contest shall not entitle the Participants to any claim or compensation against MAB, its agents and employees for any and all losses or damages suffered or incurred by the Participants as a direct or an indirect result of the act of cancellation, termination or suspension thereof.
