



TERMS AND CONDITIONS

Redemption of Enrich RM50 Physical Voucher for 2 OX Restaurant

1. The Redemption of Enrich RM50 Digital Voucher for 2 OX French Mediterranean Restaurant is organized by Enrich by Malaysia Airlines Berhad (Company No. 201401040794 (1116944-X) a company incorporated in Malaysia of having its registered office at Level 1, South Support Zone, 64000 Sepang, Selangor, Malaysia (hereinafter referred to “Organizer”)

And

2 OX French Mediterranean Restaurant (Registration 1162053-V), a company incorporated in Malaysia and having its registered office at 2 OX French Mediterranean Restaurant, 54-56 Jalan Doraisamy, 50300 Kuala Lumpur, Malaysia (hereinafter referred to as “2 OX French Mediterranean Restaurant”)

Redemption Period: 9th April 2021 – 8th April 2022 (11:59 PM, Malaysia Time)

Usage Period : Six (06) months from date of successful redemption

The Enrich RM50 Physical Voucher for 2 OX French Mediterranean Restaurant is herein referred as “**Enrich RM50 Physical Voucher**” in this Terms and Conditions.

2. The Enrich RM50 Physical Vouchers can be utilized at 2 OX French Mediterranean Restaurant only. Enrich members can use their Enrich RM50 Physical Voucher (s) as a mode of payment at 2 OX French Mediterranean Restaurant for dining purposes (including take-outs and wedding packages) and must be in a single receipt.
3. The Physical Voucher is only available in a denomination of RM 50 and each Physical Voucher redemption requires 5,000 Enrich Points.
4. Only valid original Enrich RM50 Physical Voucher will be accepted at the Restaurant and Physical Vouchers that have been deemed to have been photocopied, duplicated or which otherwise is suspected to be the subject of fraud.
5. At time of use, the member using this Enrich RM 50 Physical Voucher (s) must present his/her Enrich physical/digital card together with the Physical Voucher (s) before ordering.
6. Top up by cash/credit card is required for bills more than the Physical Voucher value. No refund of balance is required should the value of the Physical Vouchers used is more than the total payable amount.
7. In the event where the value of the RM50 Physical Vouchers used is more than the total payable amount 2 OX French Mediterranean Restaurant will not refund the balance. (eg: total bill costs RM320, customer uses 7x RM50 Physical Vouchers for payment, 2 OX French Mediterranean Restaurant will not refund RM30 to customer).
8. Payment must be either with Enrich RM50 Physical Voucher (s) in full or combination of Physical Vouchers and cash/credit card. Members may combine the Enrich RM50 Physical Voucher (s) belonging to other Enrich members to pay for the total bill cost.
9. GST and any related taxes to be settled by members separately.



10. Enrich member will not earn Enrich Points for the cash value paid with the Enrich RM50 Physical Vouchers.
11. Once utilized, the Enrich RM50 Physical Voucher, cannot be exchanged or substituted any other promotions offered by Malaysia Airlines or the participating restaurants.
