

**MALAYSIA AIRLINES**  
**STIMULUS CUTI MALAYSIA CAMPAIGN 2.0**  
**Terms and Conditions**

**A. Duration**

The Stimulus Cuti Malaysia Campaign ("Campaign") is organised by Malaysia Airlines Berhad ("MAB") and will run from 27<sup>th</sup> September 2021 until 31<sup>st</sup> December 2021 ("Campaign Period")

**B. Eligibility and Participation**

Any person who has fulfilled the criteria below is eligible to participate in this Campaign ("Participant"):

1. The first 6,500 Malaysians with a valid NRIC;

**C. The mechanics of the Campaign are as follows:**

1. Participants will need to log in using their Enrich credentials, those who are not yet Enrich members will need to sign up, and include their NRIC number as well as upload a scan copy of the NRIC to the registration page to claim a free RM100 MH Stimulus Voucher at [www.malaysiaairlines.com/cuticutimalaysia](http://www.malaysiaairlines.com/cuticutimalaysia). The free RM100 MH Stimulus Voucher with Voucher Code and PIN will be delivered via email once the details are submitted.
2. Participants who have booked from the Stimulus Cuti Malaysia Campaign 1.0 in 2020 are not eligible for the free RM100 MH Stimulus Voucher.
3. A maximum of up to 8 adult and child travelers can be added to register and avail the voucher. Scanned NRIC with NRIC number clearly visible of each traveler must be included.
4. The free RM100 MH Stimulus Voucher validation and travel period are valid from 27<sup>th</sup> September 2021 until 31<sup>st</sup> December 2021 to any destination within Malaysia only.
5. All flights must be booked on the Malaysia Airlines website or Mobile App. Any bookings made via Contact Centre, ticket offices, travel agents or any other ground channels are not eligible.
6. The free RM100 MH Stimulus Voucher does not apply to infants. It's not necessary to create profiles for infants. Parents/guardian need to add the numbers of infants to be booked at the destination's selection stage. However, a standard fare for infants is applicable.
7. A discount of RM100 will be applied in the fare once you fill out your Voucher Code and PIN at the payment page.
8. Every passenger is only allowed to claim the free RM100 MH Stimulus Voucher once for domestic flight ticket only. The free RM100 MH Stimulus Voucher is eligible for one time use only and if the total amount payable is less than RM100, the balance amount will be forfeited.

9. The free RM100 MH Stimulus Voucher is non-transferable, non-refundable, non-exchangeable for cash or kind whether in part or in full. Any unutilised MH Stimulus Voucher is non-refundable after its expiry date.
10. The free RM100 MH Stimulus Voucher is not applicable for Enrich points redemption booking.
11. The free RM100 MH Stimulus Voucher eligible to be combined with other existing MH vouchers at the time-of-flight booking with up to 3 vouchers in a single transaction per passenger. But not eligible to be combined with promotion code.
12. If the free RM100 MH Stimulus Voucher amount is not sufficient for a new booking, the remaining amount can be paid using credit card.
13. The free RM100 MH Stimulus Voucher cannot be used to pay for a date and/or flight change on MH website and mobile application. However, passengers can use other modes of payments for the same.
14. The free RM100 MH Stimulus Voucher can be used for booking with currency in MYR only, not eligible for Multi-Currency Payment (MCP) and Book Now Pay Later option
15. The free RM100 MH Stimulus Voucher is valid for one-way or return flights on Malaysia Airlines Economy and Business Class normal fares on Malaysia Airlines operated flights including on Firefly, MASwings and codeshare flights to all domestic flights with currency in MYR only. Child discount applies as per the respective fare brand.
16. In order to utilize or to make payment with the free RM100 MH Stimulus Voucher, the passenger name in a booking and voucher should be the same.
17. All other promotion code or special fares are not entitled under this Campaign.
18. Any refunds or cancellations are subject to the respective fare rules and cancelation only can be done through our call centre.
19. In case of cancellation of tickets which are booked using the free RM100 MH Stimulus Voucher, the amount paid through voucher is forfeited and will not be refunded.
20. The free RM100 MH Stimulus Voucher is not eligible for purchase of MHinsure (travel insurance) during the booking process.
21. The free RM100 MH Stimulus Voucher is also not eligible for purchase of services via Manage Booking.
22. Consent to Transfer and Use: The individual making the purchase using the free RM100 MH Stimulus Voucher has further acknowledged and agreed that by providing Malaysia Airlines with any personal or proprietary information, the individual hereby expressly give their consent to the transmission of such personal or proprietary information over international borders for the purpose of processing the relevant transactions. The individual hereby gives their further consent to the use of such personal data on an anonymized basis for statistical objectives.
23. Malaysia Airlines shall not be liable in any way whatsoever for any disruption during the free RM100 MH Stimulus Voucher transaction, whether due to

technical problems or otherwise, which is beyond its reasonable control. In the event of any disruption, reasonable effort shall be used to remedy the disruption and resume the purchased product transaction on a fair and equitable basis.

24. Malaysia Airlines reserves the absolute right to cancel, terminate or suspend the usage of the free RM100 MH Stimulus Voucher without prior notice. For the avoidance of doubt, any cancellation, termination or suspension by Malaysia Airlines shall not entitle the individual making the purchase or any Enrich member to any claim or compensation against Malaysia Airlines, its agents and employees for any and all losses or damages and any consequential damages thereof suffered or incurred as a direct or an indirect result of the act of cancellation, termination or suspension thereof.
25. The Terms and Conditions herein shall be construed, governed, and interpreted in accordance with the laws of Malaysia. The individual making the purchase agree to submit to the exclusive jurisdiction of the Courts of Malaysia over all matters arising from this free RM100 MH Stimulus Voucher transaction.
26. Malaysia Airlines reserves the absolute right to reserve or remove the free RM100 MH Stimulus Voucher converted incorrectly or not in accordance with these Terms and Conditions at any time without prior notice.
27. By participating in transaction using the free RM100 MH Stimulus Voucher, it shall be deemed that the individual making the purchase have read and agreed to be bound by these Terms and Conditions. Any breach of these Terms and Conditions may, at Malaysia Airlines' absolute discretion, result in forfeiture of any of points purchased.

29. In case your original ticket which was converted to the free RM100 MH Stimulus Voucher is eligible for one-time fare difference waiver as per MH Commercial Waiver Policy, please call our contact centre in order to avail the benefit.
30. One-time fare difference waiver can be available only when the free RM100 MH Stimulus Voucher is fully unutilised.
31. Flight tickets booked under this Campaign shall be subject to MAB's prevailing policies, rules and regulations which shall include the General Conditions of Carriage, a copy of which can be found on [www.malaysiaairlines.com](http://www.malaysiaairlines.com).
32. Other fare conditions and rules apply.

MAB reserves the right to use the Participant's name, images, comments, materials relating to this Campaign and the results of this Campaign for the purpose of any announcement or promotional or marketing purposes in any media format and any media channels without any fee being paid. The Participant shall hold MAB free and harmless from any claims and/or liabilities whatsoever resulting from the usage or the reproduction of the submitted materials by MAB. This clause shall survive the expiration of this (Campaign Period).
