https://changiairport.com/safetravel before arriving in Singapore to minimise processing time at the airport. For arrivals by land, payment will be collected on-site. You are also required to bear all medical costs incurred during your stay in Singapore.

- 5. Please note that any Visit Pass issued to you is subject to the accompanying terms and conditions as set out here. Non-compliance with any of the Terms & Conditions may result in you being refused entry or your Visit Pass being cancelled.
